

Actions by the House of Delegates at the 2010 Clarksville Convention

Kentucky-Tennessee District of Kiwanis International District Convention September 9-11, 2010 Clarksville, Tennessee

The Kentucky-Tennessee District of Kiwanis International House of Delegates approved the following:

Governor –Elect James T. Mann was elected 2010-2011 Governor of the KY-TN District of Kiwanis International.

Don Ritter was elected Governor-Elect 2010-2011.

The following amendments were presented to the House of Delegates:

AMENDMENT #1

Purpose: To remove references to 501(c) (3) from our bylaws, now that Kiwanis has been officially denied that status by the IRS.

Effective Date: Immediately

ARTICLE II OBJECTS

Section 1. The objects of this district shall be:

- a. To seek within the district and through the clubs of the district the attainment of the Objects of Kiwanis International as set forth in the Constitution.
- b. To increase the fellowship and cooperative effort of the clubs with the district.
- c. To be cooperative with Kiwanis International in building new clubs and in educating and strengthening clubs with the district.
- d. To promote participation of the clubs of the district in the general objectives, programs and policies of the district and of Kiwanis International.

These objects must be accomplished exclusively through charitable and educational activities as described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

ARTICLE XIII PUBLIC ACTIVITIES

Section 4. Notwithstanding Sections 1, 2, and 3 above, no substantial part of the activities of the district shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the district shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE XXI NOT-FOR-PROFIT ORGANIZATION

Section 1. The district shall operate as a not-for-profit organization incorporated within the laws of the States of Kentucky and Tennessee.

Section 2. The district is organized and operated exclusively for the purposes set forth in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. The Objects, as stated in Article II of these bylaws, shall be accomplished exclusively through charitable and educational activities as described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

Amendment Passed

AMENDMENT #2

Purpose: To add the office of Vice-Governor to our district, who shall normally succeed to the offices of Governor-elect, then Governor.

Effective Date: *Oct. 1, 2011*

ARTICLE V OFFICERS

Section 1. District Officers

a. The officers of the district shall be the Governor, Governor-elect, Vice-governor, Immediate Past Governor, Secretary, Treasurer, and a Lieutenant Governor for each division. *Note—After their election and before their assumption of office, all officers shall be known and designated by the titles of the offices to which they have respectively been elected followed by the term “designate”.

Section 3. Each district officer shall be an active, senior, or privileged member in good standing in a club of the district. ; and The Governor, Governor-elect, and Vice-Governor shall have a clear criminal history background check conducted and verified by Kiwanis International. Each Lieutenant Governor shall be an active, senior, or privileged member in good standing in the division from which elected.

Section 7. The Vice-governor has the further duties and responsibilities:

a. Attend the training conferences for governors-elect. Give priority to such training, orientation, and other activities that focus on education, leadership, and growth, and prepare him/her to later hold the offices of Governor-elect and Governor.

Comment: At this time, there is no plan to invite Vice-Governors to the Governors-elect Training Conference held by Kiwanis International. Rather, that person will attend the following year, when he/she becomes Governor-elect.

b. Perform such duties and responsibilities as are currently prescribed or as may be amended in the future in the Bylaws, the Kiwanis International Board Policies and Procedures, or the district bylaws.

c. Carry out such other duties and responsibilities as are from time to time assigned by the District Board of Trustee.

Current Sections 7 – 10 shall be renumbered as Sections 8 – 11.

ARTICLE X NOMINATION AND ELECTION OF OFFICERS

Section 1. Officers Other than Lieutenant Governors,

d. The nominating and election procedure for officers to be elected at the annual convention shall be as follows:

(1) The Governor-elect shall be the sole candidate for the office of Governor and the Vice-Governor shall be the sole candidate for the officer of Governor-elect.

Comment: This is one of the key provisions to establishing the office of Vice-Governor and must be included.

(2) All candidates for the offices of Governor, Governor-elect, and Vice-governor [and Secretary and/or Treasurer] must submit written notice of candidacy to the District Secretary no later than the beginning of the first business session of the annual convention. At that session, the Secretary shall make a report of the candidates giving such notice. All candidates for the office of Governor-elect shall submit a signed agreement to Kiwanis International to fulfill their duties. The Governor, Governor-elect, and Vice-Governor shall have a clear criminal history background check conducted and verified by Kiwanis International.

(3) A majority of all valid votes cast for each position shall be necessary for the election of the Governor, and Governor-elect, and Vice-Governor [and Secretary and/or Treasurer]. In the event that any ballot cast for Governor, or Governor-elect, and Vice-Governor [or Secretary or Treasurer] does not show a majority for any nominee for the foregoing offices, the Governor shall designate a time and a place for further balloting for such office. Prior to the second ballot, the nominee having the lowest vote on the first ballot shall be dropped; and on each succeeding ballot, the same procedure shall be followed until a nominee shall have received a majority of all valid voted cast.

ARTICLE XI VACANCIES IN OFFICE

Section 1. In the event of a vacancy in the office of Governor, during an administrative year, by a two-thirds (2/3) vote of the entire District Board of Trustees, the Board shall elect a Past Governor, Lieutenant Governor, or Past Lieutenant Governor who is at active, senior, or privileged member of a Kiwanis club in the district to become Governor for the unexpired term.

Section 2. In the event of a vacancy in the Office of Governor-elect or Vice-governor during an administrative year, the vacancy for the unexpired term shall be filled by the District Board of Trustees, by a two-thirds (2/3) vote of the entire District Board, from the Lieutenant Governors or Past Lieutenant Governors who are active, senior, or privileged members of Kiwanis clubs in the district.

AMENDMENT #3

Purpose: To update provisions regarding district dues collection to correspond with changes made in the collection of Kiwanis International dues.

Effective Date: October 1, 2010

ARTICLE XIV

REVENUE

Section 1. Each member club shall pay to the district for each of its members, with the exception of its honorary members, the sum of \$2.00 per annum as the subscription price of the district bulletin, and the sum of \$18.00 per annum as dues. The total amount shall be due *in an annual payment, paid not later than thirty (30) days from the date of the club invoice from Kiwanis International annually on October 1, payable not later than sixty (60) days thereafter*, and is based upon the annual membership report of the respective clubs as shown by the annual reports to Kiwanis International as of September 30. The total amount shall include all district charges other than the new member add fee and registration fees for district conventions or conferences.

PROVISO: Between October 1, 2010, and October 1, 2012:

- For clubs organized between September 1 and December 31:

- For the year 2010-11, payment shall be based on the club roster as of September 30, 2010, and shall be due October 1, 2010, and payable no later than November 30, 2010.

- For clubs organized between January 1 and April 30:

- For the year 2010-11, payment shall be based on the club roster as of Sept. 30, 2010, and shall be due December 1, 2010, and payable no later than January 31, 2011;

- For the year 2011-12, payment shall be based on the club roster as of September 30, 2011, and shall be due October 1, 2011, and payable no later than November 30, 2011.

- For clubs organized between May 1 and August 31:
 - For the year 2010-11, payment shall be based on the club roster as of Sept. 30, 2010, and shall be due February 1, 2011, and payable no later than March 31, 2011;
 - For the year 2011-12, payment shall be based on the club roster as of Sept. 30, 2011, and shall be due December 1, 2011, and payable no later than January 31, 2012;
 - For the year 2012-13, payment shall be based on the club roster as of September 30, 2012, and shall be due October 1, 2012, and payable no later than November 30, 2012.

Final Note from Governor Kleine

September 30, 2010


