## **GENERAL CONDITIONS**

This championship is a registered match. All guidelines for registered matches will be followed. All challenges and protests are resolved on the match site according to procedures outlined in the NRA Rule Book Section 16.

**RULES:** NRA Sporter Air Rifle rules shall govern this Championship

**INDIVIDUAL MATCHES** – Open to any individual who meets the eligibility requirements of NRA Rule 2.3.

**INDIVIDUAL CATEGORIES** – Only one category may be entered. (Cannot compete in both BB Match and Air Rifle Match)

Junior	Born 2002, 2003, 2004
Intermediate Junior	Born 2005, 2006, 2007
Sub-Junior	Born 2008 or Later

**PARENTAL PERMISSION:** Each team registration packet contains a parental permission form for Media Release, Medical Authorization and Liability Release for each team member. These forms must be signed by the competitor's parent or guardian and returned with the other registration forms before the competitor will be permitted to participate in the Match.

**NRA MEMBERSHIP NUMBER** – NRA membership is not required. In order to enter scores of competitors in the computer classification system, an NRA number must be used. If you are a member of NRA, indicate your membership number.

**ENTRIES CLOSE:** Individual match entries must be received no later than May 6<sup>th</sup>.  
\$100.00 Late fee will be required if entries are turned in after the 6<sup>th</sup> and until May 13<sup>th</sup>.

**ENTRIES LIMITED:** Entries are limited to first 40 competitors which is the capacity of the range for the time allowed. Persons making entries within the time limit which cannot be accepted will be notified.

**SCORING:** All targets will be scored by the Orion Scoring System

**REVIEW PERIOD:** A 30 Minute review period will begin after all targets are scored and available to all shooters. See Rule 16.1 for correct procedure.

**SQUADDING:** Will be assigned by Daisy.

**COURSE OF FIRE:** 20 Shots in each position – Prone, Standing, Kneeling in that order

**DISTANCE FIRED:** 10 meters

**RIFLE:** DAISY / AVANTI AIR RIFLE ONLY – 599, 753, 853, 887, 888, 953 and Valiant

**TARGETS:** Orion Air Rifle Targets

**TIME LIMITS:** NRA Rule 5.3.3 - The time allotted for unlimited sighting shots in the preparation and sighting in will be 8 minutes for prone position.

The time for record shots are as follows:

Prone – 20 minutes

Standing – 25 minutes

Kneeling – 20 minutes

There will be a 5-minute change over period and a 5-minute unlimited sighting in period between each position.

**AWARDS:**

**Based on the number of entries as listed below:**

**5 entries                      1<sup>st</sup> place**

**5 – 10 entries              2<sup>nd</sup> place**

**11 +                            3<sup>rd</sup> place**

Categories will only be combined when there are less than five competitors.

**Trophies will be awarded for Individual 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> places in each category, based on the number of entries:**

Junior – age 18-20	1 <sup>st</sup> through 3 <sup>rd</sup>
Intermediate Junior – age 15-17	1 <sup>st</sup> through 3 <sup>rd</sup>
Sub-Junior – age 14 and under	1 <sup>st</sup> through 3 <sup>rd</sup>
OVERALL	1 <sup>st</sup> through 3 <sup>rd</sup>
